

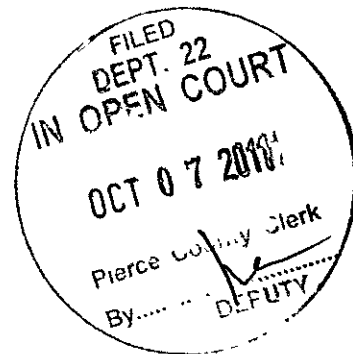
1 Even after having been given two extensions of time, Appellant/ Defendants have not
