I, Paul S. Drayna, declare as follows:


- I am an attorney admitted to practice in all Washington state courts, as 1. well as the United States District Court for the Western District of Washington. The statements in this declaration are based upon my personal knowledge, and if called as a witness, I could testify competently thereto.
- 2. I signed a previous declaration which was filed with our original application for writs of attachment. Attached to that declaration as Exhibit K was a true and correct copy of a June 3, 2014 email from me to plaintiffs' attorney, Robert Sunderland, which attached a letter from Michael Teather to Mr. Sunderland, as well as a proposed amendment to a promissory note. I personally typed that letter for Mr. Teather. The first draft was written on May 30, 2014. I finalized the letter and printed it on June 3, 2014, for Mr. Teather to sign. I personally scanned the signed letter into a PDF file, which I then personally sent by email to Mr. Sunderland along with the amendment to the promissory note.
- 3. Attached as Exhibit 1 hereto is a true and correct copy of a screen capture that I took off my work computer of the folder containing the Microsoft Word file of the June 3, 2014 letter. It shows the file was last modified on June 3, 2014, the same day it was finalized, printed, signed, scanned and sent to Mr. Sunderland by email. I have not modified, or attempted to modify these file properties, nor am I aware of any attempt by any other person to do so.
- 4. Attached as Exhibit 2 hereto is a true and correct copy of a screen capture that I took off my work computer, showing the file properties for the Microsoft Word file of the June 3, 2014 letter. It shows that the file was "created" on May 30, 2014, the day that I wrote the first draft of this letter for Mr. Teather. The file properties further show "last modified" and "last printed" dates of June 3, 2014 – the date that the letter was finalized, printed, signed, scanned and emailed to Mr. Sunderland. I have not modified, or attempted to modify these file properties, nor am I aware of any attempts by any other person to do so.

- 5. On June 10, 2014, I forwarded my June 3 email to Mr. Sunderland following up regarding my June 3 email. Because I had forwarded the original June 3, 2014 email on June 10, it had the same attachments as the original June 3 email (the letter from Mr. Teather, and the proposed amendment to the promissory note). A true and correct copy of my June 10 email is attached hereto as Exhibit 3.
- 6. On June 24, 2014, Mr. Teather sent an email to Robert Sunderland on which I was copied. A true and correct copy of that email is attached hereto as Exhibit 4.
- 7. About 90 minutes later on June 24, 2014, Mr. Sunderland responded to Mr. Teather by email, on which he also copied me. A true and correct copy of this email is attached hereto as Exhibit 5.
- 8. The "paperwork" referenced in Mr. Sunderland's June 24th email is the addendum extending the 2009 promissory note by three years. His email makes it clear that he had the document in his possession at that time, but that it had not been signed because his clients, Bob Bennion and Bob Deville, had been out of town. The only way that Mr. Sunderland could have had that paperwork in his possession on June 24th is if he had in fact received my emails of June 3rd and/or 10th. I created the loan extension document in question, and I saved it to an access restricted file folder on our company server. I did not ask or authorize anyone else to send it to Mr. Sunderland on my behalf, and I am not aware of anyone else doing so.

I declare under penalty of perjury under the laws of the United States of America that the forgoing is true and correct, executed this 5th day of December, 2016, at Seattle, Washington.
