WHEREAS, Notice and Order of Assessment No NSLOD00507 in the amount of \$3,070.00 was served, pursuant to RCW 18.27.370, on the above named Unregistered Contractor, and WHEREAS, the above named Unregistered Contractor has not filed and/or pursued an appeal with the Department of Labor and Industries within the time prescribed by law, or the Unregistered Contractor has pursued an appeal and there has been a final decision of a court determining or upholding the infraction; it is therefore declared the amount of the said assessed penalty, or the amount determined by the court, is deemed final and established, and that the balance remaining unpaid is \$3,070.00 .


NOW THEREFORE, pursuant to RCW 18.27.370, the Clerk of King County shall designate a Superior Court cause number for this Warrant and cause to be entered in the judgment docket under the cause number assigned, the name of the listed Debtor, the date of the filing of the Warrant, and the warrant amount of **THREE THOUSAND SEVENTY DOLLARS AND NO CENTS, which includes the statutory filing fee of TWENTY DOLLARS and the statutory surcharge of TWENTY DOLLARS.**

The aggregate amount of this Warrant as docketed is a lien upon the title to, and interest in all real and personal property of the debtor against whom this Warrant is issued, the same as a judgment in a civil case duly docketed in the office of such clerk, and is sufficient to support the issuance of writs of garnishment in favor of the state in a manner provided by law in case of judgment, wholly or partially unsatisfied.

Warrants shall bear interest at the rate of one percent of the delinquent amount per month or fraction thereof from and after the due date until payment, increases, and penalties are received by the department. (RCW 43.17.240)
